So, in principle, the Defense Mechanism - PAIN [2], becomes the Mechanism of Destruction of Consciousness. The most striking examples of the fact that this must be taken into account when analyzing drug addiction can be found in mentally healthy people, when they encounter Love and Betrayal, to the point of committing suicide. For mentally healthy people, there is an individual way to overcome this mental, Consciousness-destroying Pain - to cause Physical Pain, by breaking, say, the left hand with a blow from the right. Society, despite all the technical progress, often throws both reflex and mental illnesses into the same "basket".
